

Liability Release

I, _____, release all liability from Whispering Pines Pet Resort (WPPR) and/or Regina Windham, Owner of Whispering Pines Pet Resort at 4240 Hwy 49 South, Dadeville, Alabama, 36853. In case of injury, accident or illness, I do understand that Whispering Pines Boarding Kennel will take the very best care of my dog/cat(s) and every precaution for the health and welfare of my dog/cat(s).

- 1. I agree to pay the rate for boarding effective on the date the dog/cat is checked into the kennel.
- 2. I further agree to pay all costs and charges for special services requested and all necessary cost for the dog/cats(s) during the time the pet is in the care of the kennel.
- 3. By signing this contract and leaving my dog/cat(s) with the kennel, I certify to the accuracy of all information given about said pet(s).
- 4. I further understand and agree that in admitting my dog/cats(s) to Whispering Pines, staff has relied on my representation that my dog/cat(s) is/are in good health and have not harmed or shown aggression or threatening behavior towards any person or any other dog/cat.
- 5. I agree that WPPR will not be responsible or liable for lost, stolen or damage to personnel property belonging to me.
- 6. I understand and agree that WPPR and their staff and volunteers, will not be liable for any problems which develop, including but not limited to, loss by fire, theft, running away, death or injury, and I hereby release and discharge WPPR Boarding Kennel, its owner, employees and representatives from any and all claims, damages, liability and/or causes of action of any kind arising from my dog/cat(s) attendance at the kennel except where any such loss is caused by negligent of intentional act of an employee or representative of the kennel.

- 7. I specifically represent to WPPR that the dog/cat(s) have not been exposed to rabies or distemper within a 30 day period prior to boarding and that the dog(s) has all the necessary vaccinations (Rabies, Distemper (DHLPP) and Bordetella). Evidence of these vaccinations has been provided at time of boarding.
- 8. I understand that the dog/cat(s) must be treated for fleas and ticks prior to arrival. If fleas or ticks are found on the pet(s) during boarding the staff of WPPR will treat the pet(s) at the owner's expense.
- 9. WPPR will make every effort to keep all dogs safe, however, I recognize that there are inherent risks of illness or injury when dealing with animals. Such risks include, but are not limited to problems resulting from rough play and canine cough.
- 10. I am aware that my dog may co-mingle with dogs owned by different owners in a supervised environment unless otherwise specified during consultation.
- 11. If my dog/cat becomes ill, I understand that I will be notified pursuant to the contact information I have provided when my dog/cat was checked into the kennel. If I do not immediately notify WPPR regarding which measures I wish to be taken or in the event emergency action is required, in the sole discretion of WPPR, a veterinarian may be contacted and my dog/cat may be evaluated by such veterinarian or transferred to the veterinarian as deemed necessary. I agree to promptly pay for any such expenses incurred in connection with such veterinarian services.
- 12. Right to Refuse Service WPPR has the right to refuse service for any reason it deems. In the event of a dog that cannot be boarded safely without danger to the owner/employees/others, WPPR's Kennels will use muzzles, e-collars, correction leads etc. to ensure the safety of the dog and kennel staff.
- 13. I agree that my pet or I may be photographed, videotaped, or monitored for any and all marketing/promotional, social media, security surveillance, or data gathering for "Whispering Pines Pet Resort" and its website, Facebook, Instagram etc. "Whispering Pines Pet Resort" will never sell your information to a third party or release personal information without expressed written consent.
